# **INTRODUCTION & METHODOLOGY**

From March 7-14, 2021, DHM Research conducted a survey of Oregonians to assess values and beliefs about a variety of issues in the direction of the state, impressions of key leaders, legislative policies, and COVID-19, including vaccinations and school re-openings.

The research was completed as a community service by DHM Research as a community service.

**<u>Research Methodology</u>**: The online survey consisted of 600 Oregon residents ages 18+ and took approximately 15 minutes to complete. This is a sufficient sample size to assess Oregonians' opinions generally and to review findings by multiple subgroups.

Respondents were contacted by using professionally maintained online panels. In gathering responses, a variety of quality control measures were employed, including questionnaire pre-testing, validation, and real time monitoring of responses. To ensure a representative sample, demographic quotas were set, and data weighted by area of the state, gender, age, race, education and political affiliation.

**Statement of Limitations:** Any sampling of opinions or attitudes is subject to a margin of error. The margin of error is a standard statistical calculation that represents differences between the sample and total population at a confidence interval, or probability, calculated to be 95%. This means that there is a 95% probability that the sample taken for this study would fall within the stated margin of error if compared with the results achieved from surveying the entire population. This survey's margin of error is  $\pm 4.0\%$ 

**<u>DHM Research</u>**: The research was completed as a community service by DHM Research. DHM is an independent and non-partisan organization. DHM is also a Certified B Corporation.
