





#### **INTRODUCTION & METHODOLOGY**

From October 1-6, 2020, DHM Research and the Oregon Values and Beliefs Center conducted a survey of Oregonians to assess values and beliefs about a variety of issues including COVID-19, public finance and taxation, climate change, and homelessness.

The research was completed as a community service by DHM Research in partnership with the Oregon Values and Beliefs Center.

**Research Methodology**: The online survey consisted of 600 Oregon residents ages 18+ and took approximately 15 minutes to complete. This is a sufficient sample size to assess Oregonians' opinions generally and to review findings by multiple subgroups.

Respondents were contacted by using professionally maintained online panels. In gathering responses, a variety of quality control measures were employed, including questionnaire pre-testing, validation, and real time monitoring of responses. To ensure a representative sample, demographic quotas were set, and data weighted by area of the state, gender, age, and education.

**Statement of Limitations:** Any sampling of opinions or attitudes is subject to a margin of error. The margin of error is a standard statistical calculation that represents differences between the sample and total population at a confidence interval, or probability, calculated to be 95%. This means that there is a 95% probability that the sample taken for this study would fall within the stated margin of error if compared with the results achieved from surveying the entire population. This survey's margin of error, for the full sample, ranges from ±2.4% to ±4.0% depending on how the response category percentages split for any given question.

<u>DHM Research & Oregon Values and Beliefs Center</u>: The research was completed as a community service by DHM Research in partnership with the Oregon Values and Beliefs Center. Both organizations are independent and non-partisan. DHM is a Certified B Corporation and OVBC is an Oregon charitable nonprofit corporation.

### **Key Findings**

 Eighty percent of Oregonians are worried about Oregon's future — most notably, the impact that Covid-19 will have on our economy and public health infrastructure, the protests and riots in downtown Portland, and our effect on the environment in the wake of September's devastating wildfires.

- While most Oregonians are worried about their personal financial situation, thirteen percent aren't worried at all.
- Oregonians are split on the topic of taxation to improve public services. We saw an equal distribution of respondents feeling that Oregon spends too much, the right amount, and not enough on public services.
- Only a third of Oregonians said they feel we can find common ground and come together next year to address our state's challenges. The rest said we won't be able to or were unsure.
