

#### Introduction & Methodology

From August 18 – 23, 2023, DHM Research conducted an online survey of Washington residents. The purpose of the survey was to gauge Washingtonian's perceptions of the state and the economy, evaluate impressions of key leaders and organizations, and places, explore attitudes surrounding key issues like housing, homelessness, and public safety, and assess attitudes about work and jobs ahead of Labor Day.

#### Research Methodology

The online survey consisted of 500 Washington residents ages 18+ who are registered to vote and took approximately 13 minutes to complete. This is a sufficient sample size to assess Washingtonian's opinions generally and to review findings by multiple subgroups.

Respondents were members of a professionally maintained online panel. A variety of quality control measures were employed, including questionnaire pre-testing and validation. To ensure a representative sample, demographic quotas were set, and data were weighted by area of the state, age, gender, race, education, and political party.

#### **Statement of Limitations**

Any sampling of opinions or attitudes is subject to a margin of error. The margin of error is a standard statistical calculation that represents differences between the sample and total population at a confidence interval, or probability, calculated to be 95%. This means that there is a 95% probability that the sample taken for this study would fall within the stated margin of error if compared with the results achieved from surveying the entire population. The margin of error for this survey is  $\pm$  4.4%.
